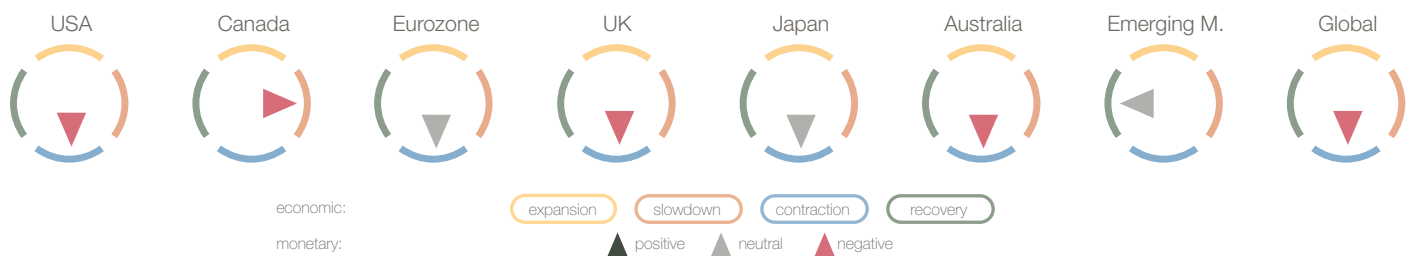
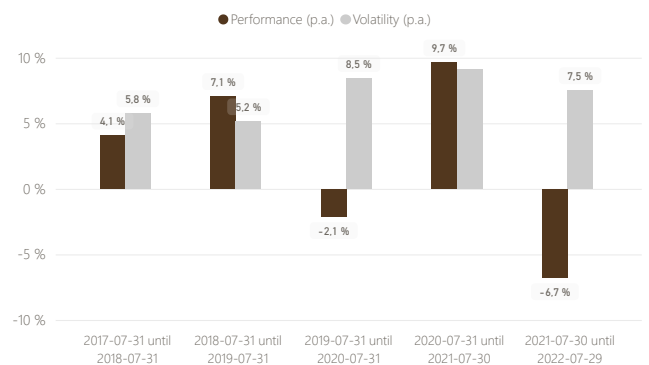
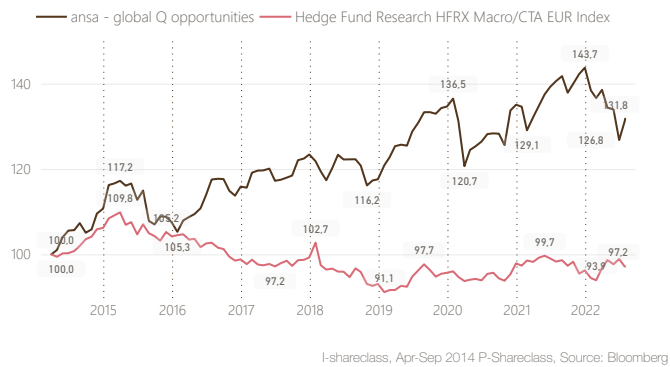

cumulative net returns since inception

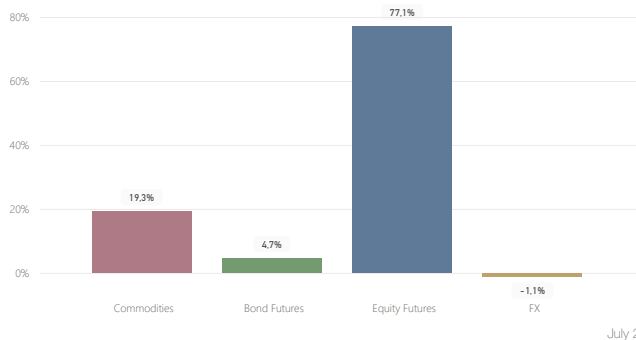

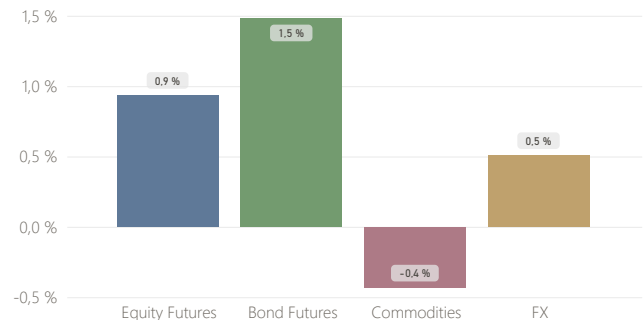

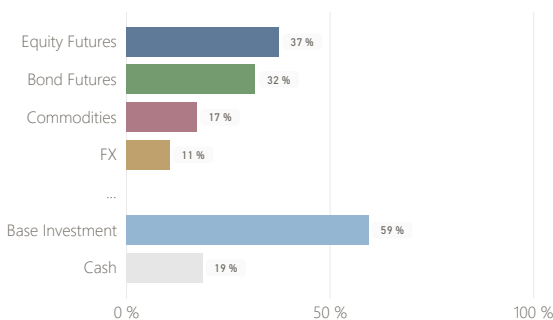
average risk contributions



performance contributions



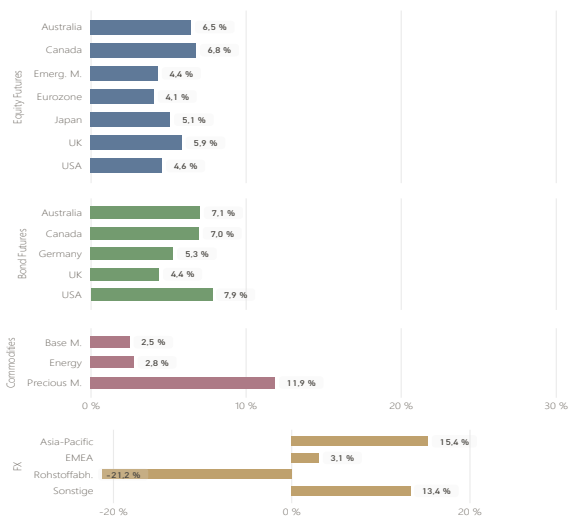
